## **State Sales Tax Revenue Totaled \$2.7 Billion in December**

Comptroller Glenn Hegar said today that state sales tax revenue totaled \$2.75 billion in December, 12.3 percent more than in December 2016.

"Double-digit growth in sales tax revenue was fueled by collections from oil- and gas-related sectors as well-drilling and completion continued to rebound," Hegar said. "But growth in tax receipts was notable across

AUSTIN - Texas all major economic sectors, including retail trade and restaurants."

> Total sales tax revenue for the three months ending in December 2017 was up 10.2 percent compared to the same period a year ago. Sales tax revenue is the largest source of state funding for the state budget, accounting for 58 percent of all tax collections.



## 5 'Healthy' New Year's Resolutions Worth Giving Up

 $(NAPSI) \hspace{-0.5cm} - \hspace{-0.5cm} Cybersecuri$ ty, as an industry, is one of the highest-paying, fastest-growing and most in demand in the U.S., yet there are not enough skilled professionals in the pipeline to fill open positions, leading to a sizable skills gap. The Bureau of Labor Statistics (BLS) finds that the demand for information security analysts who can prevent data breaches is expected to be very high over the next decade. From 2016\_2026, BLS projects employment to grow 28 percent, with 28,400 additional jobs added by 20261.

Despite the growing need, a University of Phoenix College of Information Systems and Technology survey found that only 18 percent of the 2,016 U.S. adults surveyed were interested in pursuing a cybersecurity education or profession. Cybersecurity can be a rewarding career, especially for those who want to help organizations or be part of a dynamic industry.

Maurice Gibson, assistant dean at University of Phoenix, shares five reasons to pursue a cybersecurity career in

#### 1. Cybersecurity Careers Are Here to Stay

With the rise of technology comes increases in cybercrime, according to data from Cybersecurity Ventures2. Gibson believes technology has converged with nearly all industries. meaning more companies will need trained professionals to combat hackers in the future. In fact, LinkedIn listed network information security as the sixth most in-demand skill for today's digitally advanced working world3. Cybersecurity spending is expected to exceed \$1 trillion between 2017 and 2021, finds Cybersecurity Ventures, driving the need for more qualified professionals.

2. Job Opportunities Across Nearly All Indus-

As technology converges with business, Gibson says nearly all companies will soon become tech companies, providing

cybersecurity professionals with myriad job opportunities across numerous industries4. Cybersecurity jobs are no longer shoehorned into only the government, finance or technology industries. From retail and health care to media and start-ups, cybersecurity professionals may have the option to choose an industry they most want to work in.

3. Competition for Jobs Remains Low

With more open jobs than people to fill them, competition continues to remain low in the cybersecurity workforce. The BLS projects employment of information security analysts to grow 28 percent from 2016 to 2026, much faster than the average for all occupations5. Gibson says individuals seeking a growing career with plenty of job opportunities should look no further than cybersecuri-


4. Near Top in Compensation

For many Americans, a good salary is vital for job satisfaction. Glassdoor found that nearly 70 percent of people say that compensation is among their top considerations when pursuing a job6. High salaries is another reason to pursue these careers, according to Gibson. BLS reports the median annual wage of an information security analyst is \$92,6007. Salaries can even exceed six figures in top markets as companies compete for skilled professionals8

5. Skill Set Is Transferable to a Number of Industries

With a deficit of skilled cybersecurity professionals in today's workforce, IT employees may be expected to help man. system security and infrastructure. For this reason, Gibson suggests that having cybersecurity experience can help when changing careers. He says many of the IT skill sets that cybersecurity professionals possesssuch as coding, systems administration and data analytics—can be useful résumé additions for just about any job in the tech



# Texas waits for Senate agreement on disaster aid funding

AUSTIN — Gov. Greg Abbott on Dec. 21 released a statement applauding the U.S. House of Representatives' preliminary passage of \$81 billion in disaster aid to Texas, several other states and Puerto Rico.

Abbott called the House's 251-169 vote in favor of the aid package "a step in the right direction" but added that "more needs to be done to ensure the funds Congress provides address the critical needs Texans are enduring from the largest natural disaster in our state's history. We look forward to working with the Senate to improve the disaster funding to ensure it addresses the acute needs of Texans."

The U.S. Senate went into recess on Dec. 22 without voting on disaster funding. The recess came after senators passed a continuing resolution to avoid a federal government shutdown for lack of a budget agreement.

'1115 Waiver' extended Gov. Abbott on Dec. 21 announced that the Texas Health and Human Services Commission and the federal Centers for Medicare and Medicaid Services reached a hospital funding agreement for the next five years.

"The new 1115 (Demonstration) Waiver ensures that funding will remain available for hospitals to treat and serve people across our state who are in need of top-quality healthcare," Abbott said.

"We are a state that is committed to providing quality healthcare to our people," added Texas Health and Human Services Commissioner Charles Smith. "With this agreement, we will continue our innovative approach to providing healthcare to millions of Texas Medicaid clients. We're committed to delivering a sustainable healthcare system over the long term while being good stewards of taxpayer dollars."

Safety-net hospital administrators cheered the extension.

#### AG gives gun opinion

Texas Attorney General Ken Paxton, in an opinion released Dec. 21, said licensed handgun owners could carry loaded weapons into Texas churches that do not have posted signs banning weapons.

Lt. Gov. Dan Patrick requested the opinion on Dec. 1, asking Paxton to expedite his response "so that churches may know what legal options they have to improve security' in the aftermath of the Sutherland Springs tragedy, in which a lone gunman entered a church, killing 25 people and in-

jured 20 others on Nov. 5. "If a church decides to exclude the concealed or open carrying of handguns on the premises of church property, it may provide the requisite notice, thereby making it an offense for a license holder to carry a handgun on those premises," wrote Paxton.

"However, churches may instead decide not to provide notice and to allow the carrying of handguns on their premises. Unless a church provides effective oral or written notice prohibiting the carrying of handguns on its property, a license holder may carry a handgun onto the premises of church property as the law allows," Paxton added.

#### Unemployment rate falls

The Texas Workforce Commission on Dec. 22 announced the Lone Star State's seasonally adjusted unemployment rate fell to 3.8 percent, the lowest unemployment rate recorded in four decades.

Also, the Texas economy added 54,500 seasonally adjusted nonfarm jobs in November and annual statewide employment growth increased to 2.7 percent in the month of November, marking 91 consecutive months of annual growth.

"The addition of 330,600 jobs over the year demonstrates the consistency with which employers in our state create job opportunities for the highly skilled Texas workforce," said Texas Workforce Commission Chair Andres Alcantar.

#### Problem: Aging technology

The Office of the Comp-

troller, in its December-January issue of "Fiscal Notes," examines our state government's "aging information technology infrastructure and the challenges it faces in serving a population growing by nearly half a million residents a year."

Some state agencies are running on archaic programming language dating back to the 1950s, Texas Comptroller Glenn Hegar said. "Each year, the state spends hundreds of millions of dollars on maintaining these outdated systems, and updating or replacing them would cost even more," Hegar added.

The state spends more than \$300 million annually on maintaining older hardware and software that no longer are supported by their makers, according to an estimate made by the Texas Department of Information Resources.

## Social Security Matters

Ask Rusty - When Should I Apply for Social Security?

Dear Rusty: I will be turning 62 in 2018; birth date 9/24/ 1955. My husband is 77 and receiving Social Security. Longevity runs in my family. I have been self-employed all my life. I am still working and my husband collects a pension, Social Security and RMD from a traditional IRA, so there is no need for additional monies under my current circumstances. When should I start taking Social Security? Signed: Thinking about Retire-

Dear Thinking: The question of when to take Social Security normally gets an answer of "It depends on your health, your family history of longevity, and vour need for the money" You've already addressed those items so I'll focus on your main question - when should you start taking Social Security?

Even though you'll be eligible to collect Social Security when you turn 62, if you do so you will only get 74.17% of the retirement benefit you would be entitled to at your full retirement age (FRA). Whenever you apply, you will be deemed to be filing not only for your own retirement benefit but also any spousal benefit you may be entitled to from your husband's work record. Similar to your SS retirement benefit, your spousal benefit would also be reduced because you took it early; instead of being 50% of your husband's benefit at your FRA, you would only get 35% at age 62 (if that is larger than your own retirement benefit). The point I'm making is that by claiming SS early, any benefit you're entitled to will be reduced from what you would get at your full retirement age.

Just as you are penalized for claiming before your full retirement age, you are rewarded for waiting beyond it to claim Social Security retirement benefits. In fact, for each year you wait beyond your full retirement age, your retirement benefit will be 8% higher than it would be at your FRA. That will continue up until you are 70 years old when your retirement benefit will be 30.67% higher than it would have been at your FRA. You stop earning additional credit at age 70, so there's no reason to wait beyond that to apply. Let's use an easy example to illustrate: If your FRA retirement benefit is \$1000, by applying at age 62 you would only get \$741 per month instead of \$1000. But if you wait until you are 70 to claim benefits, you would get \$1306 per month, nearly twice what you would get by applying at age 62.

There are two other factors you should incorporate into your

1) At your FRA, you will be entitled to \_ of your husband's benefit at his FRA. If your spousal benefit at your FRA is substantially more than your own retirement benefit, then applying at your FRA may be a good strategy, as opposed to waiting and earning delayed retirement cred-

2) Once you have reached your FRA you will be entitled to 100% of your husband's benefit amount if he should predecease you. If your eventual survivor's benefit would be more than your own FRA benefit amount, you might be better served by claiming your retirement benefit earlier

As you can see, most of the answer to your question depends upon whether your benefits as a spouse or a survivor will be more than your benefit based upon your own work record. If not, then waiting beyond your FRA up to age 70 will yield you the maximum retirement benefit. But if your spouse and/or survivor's benefit will be more than your own retirement benefits, then applying at your full retirement age may be the best strategy. If you haven't already done so, I suggest you go to www.ssa.gov and set up your personal "My Social Security" account which will give you access to your currently estimated retirement benefit. Comparing that to your potential spousal and survivor benefits should give you the answer you're seeking.

## Many Candidates Compete, Fire Department Urges Citizens to be

The 29th Congressional District of Texas runs in a circular manner, from North Houston, Aldine, through East Harris County communities such as Baytown, Galena Park, Jacinto City, Pasadena and South Houson.

nine Republicans and five Democrats will try to win a spot on the November general election for this posotion.

Also contested in the primary and general election will be Senator Ted Cruz, up for re-election after his first six year term. He is opposed by four Republicans, and three Democrats including front-runner Beto O'Rourke from El Paso.

These elections have national significance, as the House and Senate could lose their Republican majorities in November.

Another interesting Texas race is the governor, where 10 Democrats are running in the primary to oppose Governor Greg Abbott, and two Republicans.

Because of the large numbers of candidates running in each of these races, it is anticipated that there will be a run-off election in some, which is scheduled for May 22

Candidates for the TX29 seat given up by retiring Congressman Gene Green include Democratic frontrunner State Senator Sylvia Garcia, real estate agent Dominique Garcia, Houston Attorney Roel Garcia school teacher Hector Morales, and Beaumont area businessman Tahir Javed.

The 29th District was originally set-up to represent the 77% Hispanic population in that area of Harris County, and runs from Greenspoint and Aldine through East Harris County and Pasadena. It includes all of the cities of Galena Park, Jacinto City, and South Houston, and parts of Baytown. Houston. and Pasadena. With all the Garcia-named candidates running, there is a strong possibility this year that an Hispanic will end up as the candidate. Up until now Gene Green, a non-Hispanic, has won the seat every 2 years since 1992, a testiment to his responsiveness to his constituents and their needs. The first year, 1992, he won by only 180 votes out of 31,000 cast in a runoff but since then he has had solid victories. The population of the 29th District is approximately 758,000 people.

Since all the Democratic candidates but Javed have Hispanic names and heritage, it is likely that this district will finally be represented in Congress by a Hispanic, and perhaps a woman. State Senator Svlvia Garcia laughs at so many Garcias running, and says "You're talking to the real Garcia" when asked to comment. Green has endorsed Sylvia Garcia for the position shortly after announcing his retirement. One other possible candidate was State Representative Armando Walle, who worked for Green for several years, but Walle has decided to return to the State Legislature instead.

Two candidates will be on the Republican primaballot, Schafranek and Phillip Aronoff. However, the voters in the district are heavily Democratic.

In District 2, retiring Congressman Ted Poe's seat will be competed for by Rick Walker, Kathaleen Wall, David Balat, and six other Republicans and five Democrats.

Early voting for the Primary starts February 20th, earlier than most other states, and may determine the outcome. It is expected that nearly half the votes will be cast early.

# Safe when using Heating Devices

With low temperatures, the Houston Fire Department urges citizens to be careful and follow some simple safety tips when using space heaters, fireplaces and other supplemental heating sources. Any shift away from the exclusive use of central heating presents an increased possibility for fire.

Citizens should always keep in mind that: Space Heaters Need Space. The Houston Fire Department recommends the following safety tips when using supplemental heating sources:

- •Make sure you have a working smoke alarm.
- Never leave children unattended in a room with a space heater
- Children knock over space heaters especially if they are placed on top of wobbly tables or stools and near where the children play. Children may also stick paper or toys in the grates of the space heaters especially gas space heat-
- Keep all combustible materials, including yourself at least 3 feet from the heater
- Open face heaters should have a screen
- Provide ventilation to prevent carbon monoxide poisoning

Vented Gas / Fired Heating Appliances Tips -Central heating units, floor furnaces, recessed wall heaters, and vented space heaters.

- Inspect annually by a qualified service techni-
- Do not use these type units without a proper vent pipe. Vent pipes must exhaust to the outside!
- If your flame is not blue, it is not burning properly. It is producing Carbon Monoxide, which can't be seen, smelled or tasted. Turn it off.
- Use flexible metal tubing with threaded ends to connect the heater to the gas valve. There should be a cutoff valve for the heater at the wall. Never use a rubber hose to connect a space heater to the gas valve!
- Use soapy water to check all connections and valves for leaks. NEVER use a match to test for a gas leak!
- Look for the American Gas Association label and follow the manufacturer's recommendations for proper usage.

Electric Heaters Tips · Never overload outlets

- or breakers
- Don't use extension cords for the heater. If the cord is hot to the touch, turn off the heater and unplug it!
- Electric heaters permanently installed in the wall or ceiling should have lint and dust removed reg-



tion Association (NFPA) According to the NFPA While fireplaces often conjure up images of warmth and comfort, they also represent a source of home heating fires. Creosote - a sticky, oily, combustible substance created when wood does not burn completely - rises into the chimney as a liquid and deposits on the chimney walls, and plays a role in nearly one-fourth (23%) of all home heating fires each

Just like a space heater, keep anything that can burn at least three feet away from a fireplace, and create a three-foot "kidfree zone" around open

- Make sure the fireplace has a sturdy screen to stop sparks from flying into the room
- Never leave a fireplace fire unattended, particularly when children are present
- Ashes should be cool before putting them in a metal container, and kept at a safe distance from your home.
- Make sure you open your fireplace flue, if applicable. There have been several fires this month because citizens left the flue closed.
